

Suunto Cashback Terms and Conditions

ARTICLE 1 - PARTICIPANTS

1.1 This promotion is only open to Participants. A Participant (“Participant”) is a person or a legal entity (company) who is resident in Australia. Employees of Amer Sports Australia Pty Ltd, its subsidiary companies, their families, agents and other parties directly involved with this promotion are not eligible to enter. The promotion is only open to Participants purchasing for their own use i.e. end users. Amer Sports Australia Pty Ltd (“Amer”) reserves the right to verify the eligibility of Participants and/or to exclude Participants at its sole discretion at any time for any reason.
